I've been very involved in the State Association since going to my first conference in Fall of 2016 as an alternate director. I have not missed a conference since, though I did miss a Hill day due to Covid. I have been very active in the legislative steering committee, on the PAGs that I've been assigned to, as well as any other work the association has thrown my way.

I serve as the vice-chair of the Washington Real Estate Commission, on the board of the Bellevue Chamber of Commerce, as well as the Seattle Aquarium. I am part of the Policy committee at the Bellevue Chamber, as well as the PLUSH (Permitting, Land Use, Sustainability, & Housing). I was also the past chair of the East King County Chamber Legislative Coalition. At the Seattle Aquarium, I am on the Public Partnership Committee. I previously served on the Bellevue Schools Foundation's Community engagement committee, Marketing Committee, as well as the Major Donors Committee. I previously served on the board of the Washington Chess Foundation's Tournament Coordinator, and currently their Event Coordinator.

What do you think is the most important aspect of the Strategic Plan?

I think the most important part of the Strategic plan is membership engagement. Our organization would not exist without our members, and everything we do on the GA side is for our members. RPAC all comes from our members. Without our membership, our ability to affect positive change in our community would not be possible.

What do you see as strengths/weaknesses in the Strategic Plan?

Our biggest strength of our Strategic Plan is the interplay between all the different pillars. Each pillar, each core committee, department succeed because they all support each other. GA is successful because of our members, not just the officers and volunteers, but every individual member. The GA successes also helps more members engage with us and helps create a great value proposition for RPAC, which helps us expand our reach in Olympia. DEI, YPN, & WCR all help identify and develop future leaders of our organization, and help us create a collabrative winning cycle.

1. What do you think are the key issues facing the Association over the next two years?

Over the next two years, the biggest issue we face is a possible soft landing or recession. How do we keep our members successful in a downturn, how do we help create an environment that they can still continue to take care of themselves and/or their family. No other issue is as big as protecting our members ability to make a living.

More legislative wins to create more housing, more educational opportunities for our members to learn, creating skillsets and opportunities for our members to engage in their community and be able to build their clientbase.

3. In previous leadership positions how did you handle instances of budget surplus or deficit?

Budget Surpluses are always nice, and we have been lucky that in the past few years, that has been the case across the board. For those organizations that have done a good job of minimizing wasted costs, saving money, reducing debt load, will be in a better position to take advantages of any opportunities during a budget deficit.

4. What steps can WR take as a leadership position to ensure that REALTORS® are the source of information for the real estate industry in the state of Washington?

Realtors can't be the source of information for their community if we don't give them the information in the first place. Member outreach and talking points for our members help every REALTOR be a reliable source of information for their community.

5. How are you going to keep Directors involved in committees?

At the 2017 Leadership Academy, we had a speaker named Mark Smiley. He talked about the rings of involvement and how we need to create different levels of commitment for people so they can feel comfortable stepping in with different levels of time commitment. There is a different level of time commitment between PAGs, Committees, and Leadership. Creating more PAGS, opportunities for members who are not engaging at a committee level, gives them a good introduction to the work of committees with a lower time commitment. That should help engage more people to committees.

6. How will you effectively deliver the information you receive from the committees to the Directors and members?

This is a team effort and not something one person can do by themselves. We can support our communications subcommittee and be committed to their recommendations on how we can reach each and every REALTOR. Part of being a good leader is to understand that you can't be an expert on everything, so you have to rely on those who know better than you, and we are stronger with everyone's input.
